

RewardStations Privacy Policy

RewardStations (“we”, “our”, or “us”) respects your privacy and is committed to protecting your personal data. This Privacy Policy explains how we collect, use, share, and safeguard information when you access or use RewardStations (the “Service”).

1. Scope of this Policy

This Privacy Policy applies to all users of RewardStations, including visitors, registered users, and members of our Telegram community.

2. Information We Collect

We may collect the following categories of information:

2.1 Personal Information You Provide

- Name, email address, phone number (if provided)
- Account login credentials
- Proof submissions or support communications
- Payment details (only when cash-out becomes available)

2.2 Automatically Collected Data

- IP address, device identifiers, browser type
- Pages visited, clicks on offers, and usage activity
- Log and security data

2.3 Cookies and Tracking

We use cookies and similar technologies to improve user experience, understand usage, and provide secure access. You may disable cookies in your browser, but some features may not work properly.

3. How We Use Your Information

We process personal information for the following purposes:

- To create and manage your account
- To provide access to offers and reward tracking
- To verify offer completion and prevent fraud
- To communicate platform updates and support
- To comply with legal and regulatory obligations

4. Legal Basis for Processing (NDPR)

RewardStations processes personal data in accordance with the Nigeria Data Protection Regulation (NDPR). Our lawful bases may include:

- Your consent
- Performance of a contract (providing the Service)
- Compliance with legal obligations
- Legitimate interests such as fraud prevention and platform security

5. Sharing of Personal Data

We do not sell your personal data. We may share information with:

- Service providers (hosting, analytics, communication tools)
- Law enforcement or regulators where required
- Partners involved in offer campaigns (only as necessary)

All third parties are required to protect your data.

6. International Data Transfers

Your data may be processed outside Nigeria where our service providers operate. Where this occurs, we take steps to ensure appropriate safeguards consistent with NDPR.

7. Data Retention

We retain personal data only as long as necessary for the purposes described in this Policy, including legal, accounting, and fraud-prevention requirements.

8. Your Rights Under NDPR

Under NDPR, you may have rights to:

- Request access to your personal data
- Request correction or deletion
- Withdraw consent at any time
- Object to certain processing
- Request data portability

9. Data Security

We implement reasonable administrative, technical, and organisational measures to protect your data. However, no system can guarantee complete security.

10. Children's Privacy

RewardStations is not intended for children under the age of 16. We do not knowingly collect data from minors.
